

**IBERVILLE PARISH COUNCIL MINUTES  
BOARD OF REVIEW, TUESDAY, SEPTEMBER 20, 2022**

The Parish Council of Iberville Parish, State of Louisiana, met in Special Session at the regular meeting place of the Parish Council, in the Council Meeting Room, 58050 Meriam Street, Plaquemine, Louisiana, on Tuesday, the 20<sup>th</sup> day of September, 2022.

The Council Chairman, Matthew H. Jewell, called the special meeting to order at 6:10 p.m. followed by the roll call with the following Council Members in attendance: Shalanda L. Allen, District 1; Chasity B. Easley; District 2; Thomas E. Dominique, Sr., District 3; Leonard Jackson, Sr., District 4; Steve C. Smith, District 5; Raheem T. Pierce, District 6; Ty J. Arnold, District 7; Hunter S. Markins, District 8; Louis R. Kelley, Jr., District 10; Timothy J. Vallet, District 11; Matthew H. Jewell, District 12; Bart B. Morgan, District 13.

A quorum was present and due notice had been posted and published in the Plaquemine Post South newspaper on the 15<sup>th</sup> day of September, 2022.

Assessor, Mr. Randy Sexton was also in attendance.

Chairman Jewell stated the purpose of the meeting, was to sit as the “Board of Review” for Ad Valorem tax appeals to consider any appeals by Parish taxpayers received by the Parish Council.

The Council Clerk did not receive any appeals. Assessor Sexton stated the open book period was from August 16, 2022 through August 30, 2022 for citizens to come in and inspect their taxes.

There was one appeals to be considered for the assessed values for the tax year of 2022 during this open book period but it was withdrawn. There were no other appeals processed through the Assessor’s office.

The taxable value of the 2022 roll is estimated at approximately \$987,052,615. The 2021 taxable value was approximately \$769,763,545 with a difference of \$217,289,070. The overall increase is about 22%, attributed to an increase in Taxable Values as follows; Personal Property \$171,213,930; Real Property \$4,463,340; Public Service \$323,990 and Industrial Tax Exemptions \$41,287,810.

The floor was opened to comments and questions. There was no one present from the public and no opposition.

The tax roll was accepted as presented by the Iberville Parish Assessor and no changes were made by the Board of Review.

Upon a motion by Councilman Vallet, and seconded by Councilman Pierce, it was moved to accept the tax roll for the year 2022 as presented by the Assessor with no changes being made.

The motion having been duly submitted to a vote was duly adopted by the following ye and nay votes on roll call:
