#### **ORDINANCE IPC# 002-23**

## ORDINANCE TO AMEND SECTION 3-22 OF THE COMPILED ORDINANCES OF IBERVILLE PARISH PERTAINING TO RABIES VACCINATION

WHEREAS, Section 3-22(d) of the Compiled Ordinances of Iberville Parish currently provide as follows: "Rabies tags shall be renewed annually during their anniversary month."

WHEREAS, current acceptable veterinarian practice allows a licensed veterinarian to vaccinate dog or cats either annually or tri-annually. The current Iberville Parish Ordinance does not allow a licensed local veterinarian to utilize a three (3) year rabies vaccine.

WHEREAS, Section 3-22(b) should be amended to provide that a licensed veterinarian may utilize an annual or tri-annual rabies vaccination for dogs and cats.

NOW, THEREFORE, IBERVILLE PARISH ORDINANCE NUMBER 3-22(b) shall be amended to read as follows:

"It shall be unlawful for any person to own, keep, maintain, harbor or possess any dog or cat in the Parish unless such dog or cat, if it is over four (4) months old, is vaccinated with an annual or tri-annual rabies vaccine by a licensed veterinarian either annually or tri-annually on the anniversary month the vaccine was administered and a tag evidencing such annual or tri-annual vaccination is affixed to the animal's collar or harness."

#### **ORDINANCE IPC# 003-23**

# ORDINANCE TO AMEND THE IBERVILLE PARISH COUNCIL PERSONNEL POLICY HANDBOOK RELATED TO ANNUAL LEAVE

WHEREAS, the Revised Personnel Policy Handbook for Council employees was adopted on February 21, 2017.

WHEREAS, the Personnel Policy Handbook provides permanent Parish Council employees with Annual Leave and Sick Leave.

WHEREAS, this amendment is to clarify the use of Annual Leave and Sick Leave by Parish Council employees.

WHEREAS, the current Personnel Policy Handbook on Page 8 entitles Annual Leave, Section C, provides... This provision does not modify the Parish's position on accumulated annual leave as

stated in prior publications, it merely clarifies the Parish's original policy as it regards accumulated annual leave."

WHEREAS, the above provision is being clarified to clearly state the Parish Council policy related to "Annual Leave" for Parish employees to provide as follows: "Accumulated Annual Leave shall NOT be utilized by Parish employees for Sick Leave EXCEPT when a Parish employee is out on approved qualifying Family and Medical Leave(FMLA) and all available sick leave has been used then only then may available annual leave be utilized in lieu of sick leave while the employee is out on approved qualifying Family and Medical Leave." NOW, THEREFORE, BE IT ORDAINED BY THE IBERVILLE PARISH COUNCIL as follows:

#### SECTION C. ANNUAL LEAVE:

The following sentence shall be REMOVED from the Personnel Policy Handbook, "This provision does not modify the Parish's position on accumulated annual leave as stated in prior publications, it merely clarifies the Parish's original policy as it regards accumulated annual leave."

The following sentence shall be ADDED to the Personnel Policy Handbook, "Accumulated Annual Leave shall NOT be utilized by Parish employees for Sick Leave EXCEPT when a Parish employee is out on approved qualifying Family and Medical Leave (FMLA) and all available sick leave has been used, then and only then may available annual leave be utilized in lieu of sick leave while the employee is out on approved qualifying Family and Medical Leave."

#### **ORDINANCE IPC# 004-23**

### ORDINANCE TO INCREASE THE COMMERCIAL GAS METER DEPOSIT FOR THE IBERVILLE PARISH UTILITY DEPARTMENT

WHEREAS, there has been a substantial increase in the number of commercial gas customers that have closed the commercial establishment without payment of the outstanding natural gas account balance due.

WHEREAS, the Iberville Parish Utility Department is obligated to collect all outstanding commercial natural gas accounts in accordance with established accounting and auditing regulations.

WHEREAS, the current residential natural gas meter deposit is the sum of seventy-five dollars (\$75.00) and the current commercial natural gas meter deposit is the sum of one hundred dollars (\$100.00).

WHEREAS, in view of the number of defaulting payments by commercial gas customers, the gas meter deposit for commercial customers should be increased from one hundred dollars to five hundred dollars for each commercial gas customer effective immediately.

NOW, THEREFORE, BE IT ORDAINED by the Iberville Parish Council as follows:

"That effective immediately the meter deposit for commercial natural gas customers shall be increased from one hundred dollars (\$100.00) to the sum of five hundred dollars (\$500.00)"

### **RESOLUTION IPC# 2023-007**

# RESOLUTION OF THE IBERVILLE PARISH COUNCIL APPROVING MAGNOLIA POWER, LLC FOR PARTICIPATION IN THE INDUSTRIAL TAX EXEMPTION PROGRAM IN IBERVILLE PARISH, LOUISIANA

The following resolution was offered by Councilman Jackson and seconded by Councilman Kelley.

WHEREAS, Louisiana Constitution of 1974, Article 7, Section 21(F) pursuant to the administrative procedure act, LA R.S. 49:950, et seq and LA R.S. 36:104 provide for the Board of Commerce and Industry (BCI) with approval of the Governor to approve contracts for the exemption of ad valorem taxes of a new manufacturing facility or an addition to an existing manufacturing facility, on such terms and conditions as the BCI with the approval of the Governor deems in the best interest of the State;

WHEREAS, MANGOLIA POWER, LLC has applied for an Industrial Tax Exemption APPLICATION (ITE), No. 20220115-ITE-\$280,692,788.00 and has the approval of the BCI for a contract granting the exemption;

WHEREAS, ITE contracts should be premised upon job and payroll creation or retention at new or expanded manufacturing facilities and that the percentage of exemption be 80% for a term of five years, and renewable for an additional term of five years from "ad valorem taxes" in accordance with Louisiana law.

NOW THEREFORE, BE IT RESOLVED, by the Iberville Parish Council as follows, after public discussion held on March 21, 2023, the Iberville Parish Council approves the terms of the ITE contract (Cooperative Endeavor Agreement between the State of Louisiana, Office of Economic Development and Magnolia Power, LLC to the exemption contract between the BCI and Magnolia Power, LLC with respect to the Magnolia power generation facility located in Iberville Parish, Louisiana, based on the conditions contained in Contract For Exemption of Ad Valorem Taxes, Application Number 20220115, a copy of said contract is attached to this resolution and made a part hereof.

WHEREAS, the ITE Iberville Parish Impact Summary for All Affected Taxing Bodies for the ten-year tax abatement at 80% exemption rate prepared by the Iberville Parish Assessor's Office is attached hereto and incorporated by reference.

WHEREAS, in the event Magnolia Power, LLC fails to complete its project, or fails to timely meet is performance objectives, job creation positions or, job retention positions requirements or maintaining payroll amounts as contained in ITE Contract No. 20220115 within the time and for the term agreed, or if Magnolia Power, LLC reduces its employment number or payroll amount to less that 90% of the required amount, such shall constitute a default under the award agreement and LED and the Iberville Parish Council shall retain the rights to modify or terminate the terms and conditions of the ITE incentive according to Louisiana law.

The Iberville Parish Council authorized the LA Department of Economic Development and BCI to include this resolution to the ITE contract between the BCI and Magnolia Power, LLC.

THEREFORE, BE IT RESOLVED BY THE IBERVILLE PARISH COUNCIL that a copy of this resolution be forwarded to the LA Department of Economic Development and BCI.

#### **RESOLUTION IPC# 2023-008**

### RESOLUTION SUPPORTING SECOND AMENDMENT AND DECLARING IBERVILLE PARISH AS A SECOND AMENDMENT SANCTUARY PARISH

WHEREAS, the Right of the People to Keep and Bear Firearms is guaranteed as an Individual Right under the Second Amendment to the United States Constitution and Article 1, Section 11 of the Louisiana Constitution of 1974.

WHEREAS, the Right of the People to Keep and Bear Arms for the defense of life, liberty and property is regarded as an Inalienable Right by the law-abiding citizens of Iberville Parish, Louisiana.

WHEREAS, the Citizens of Iberville Parish, Louisiana derive benefits from all safe and lawful forms of firearms for recreational purposes including hunting and target practice at the Iberville Parish Council Firing Range and gun collections.

WHEREAS, the members of the Iberville Parish Council, being elected to represent the Citizens of Iberville Parish, Louisiana and being duly sworn by their Oath of Office to uphold the United States Constitution and Constitution of the State of Louisiana

NOW, THEREFORE, BE IT RESOLVED that the Citizens of Iberville Parish, Louisiana, do hereby oppose the enactment of any legislation that would infringe upon the Right of lawabiding Citizens to keep and bear arms and oppose any legislation which restricts the Right of lawabiding Citizens to keep and bear arms.

NOW, THEREFORE BE IT FURTHER RESOLVED that if the Government shall infringe upon the Right to Bear Arms granted by the U. S. Constitution and Louisiana Constitution, Iberville Parish, Louisiana shall become a "sanctuary Parish" for all lawfully owned firearms possessed by its Citizens.
