Dear Taxpayer:

Please be advised that the University Club Center Economic Development District (UCC EDD) has two physical addresses assigned within its boundaries and is located within the City of St. Gabriel Corporate Limits. The physical addresses within the District are 735 and 745 E. Highway 30, St. Gabriel, LA 70776.

All dealers must charge 7.666% sales and use taxes on all sales, leases, rentals and repair transactions of tangible personal property that is delivered or consumed within the boundaries of the District. These sales transactions shall be reported using Column D (7.666%) on the Iberville Parish Sales Tax Report.

**All other sales, lease, rental and repair transactions of tangible personal property that are delivered or consumed within the City of St. Gabriel Corporate Limits and is outside of the UCC EDD must charge 5.666% sales and use tax rate. These transactions shall be reported using Column B (5.666%) on the Iberville Parish Sales Tax Report.**

**It is essential that all sales tax software be properly programmed to reflect the correct sales and use tax rate charged based upon the physical addresses located within the boundaries of the UCC EDD upon receipt of this notice.**

Dear Taxpayer:

Please be advised that pursuant to ACT 87 of the 2022 Regular Session of the Louisiana Legislature, Iberville Parish will change the interest rate assessed on unpaid sales taxes for all taxing jurisdictions. **Effective January 1, 2023, the interest rate assessed on unpaid sales taxes shall be one (1) percent per month until paid. This change will be effective beginning December 2022 sales tax period and future periods going forward. The change will affect all columns listed on the Iberville Parish Sales Tax Report (Columns A -5.000%, B - 5.666%, and D -7.666%).**

**It is essential that all sales tax software be properly programmed to calculate the new interest rate assessed on unpaid sales taxes of one (1) percent per month effective January 1, 2023.**
