## IBERVILLE PARISH COUNCIL MINUTES REGULAR MEETING, TUESDAY, APRIL 16, 2024

The Parish Council of Iberville Parish, State of Louisiana, met in Regular Session, in the Council Meeting Room, 2<sup>nd</sup> Floor, Courthouse Building, 58050 Meriam Street, Plaquemine, Louisiana, on the 16<sup>th</sup> day of April, 2024.

#### PRESIDENT'S REPORT

President Daigle reported on the following:

- He presented the council the GIS mapping system that will be available to them to better assist residents in their area. The GIS map will be customized to their respective districts to allow them to see drainage canals, trash pick up days and other helpful information. He presented the council with a demonstration of the mapping software.
- He provided the Council with the dates for community meetings that will happen at the end of April and beginning of May. He reminded the Council of the Chamber of Commerce Spring membership meeting.
- He stated that April 26<sup>th</sup> is Autism Awareness Day in Iberville and asked everyone to wear blue in support of Autism Awareness.
- The permits for the Bayou Pigeon boat ramp project has been approved and that project will begin soon.
- He stated that there is a bill being presented to the Legislatures later in the week, is House Bill 273, which would limit the terms of parish presidents, councilpersons, and police jurors and mayors and city aldermen. This proposal would be a constitutional amendment to the state constitution.
- Councilman Smith asked President Daigle what can be done at a Parish level to address some zoning concerns in this district. Iberville does not have a zoning board. He stated that he is looking at creating a zoning board. It is a lengthy process that will take time.

#### FINANCIAL REPORT

Finance Director, Randall Dunn stated that there is an election for the tax renewal for Fire Protection District 1 and Fire Protection District 2. In preparation for Hurricane season standby contracts for debris removal and the aquadam is in the works. The finance department is working on the audit and it is due by June 30, 2024. Next month we will introduce an ordinance to roll back the millage rates for 2024.

# RESOLUTION IPC# 2024-008 RESOLUTION AUTHORIZING PARTICIPATION IN THE ACADIANA WATERSHED DISTRICT, AS CODIFIED BY LOUISIANA ACT 323

The Acadiana Watershed District shall be domiciled in Lafayette Parish as a central location within the boundaries of the Acadiana Watershed District. IBERVILLE PARISH designates the Acadiana Planning Commission as the office of the Acadiana Watershed District's business operations and as the public fiscal agent and administering body to conduct daily operations as stated in Louisiana Act 323. IBERVILLE PARISH will assist in adopting the administrative steps to establish the Acadiana Watershed District Board of Commissioners and the bylaws of the District.

**WHEREAS**, the Acadiana Watershed District was formed to promote drainage and flood-risk reduction within the boundaries of the district; to promote and support a unified effort to address drainage and flood issues in the region in cooperation with local, state, and federal agencies;

**WHEREAS**, the Acadiana Watershed District has the responsibility to identify local public sources of revenue for project funding, watershed programming, and local match requirements for the provision of drainage and flood risk reduction projects;

**WHEREAS**, the Acadiana Watershed District was established to cooperate with local, state, and federal entities engaged in planning and construction of drainage and flood reduction and mitigation projects in the state and region; and to cooperate with local and state entities engaged in establishing best practice development standards for flood-risk reduction and mitigation in the region;

WHEREAS, the foregoing coordination embraces outreach with local communities to build support for regional watershed management approaches, located within and outside of the district, that can more effectively address mounting water risks within the district boundaries; WHEREAS, coordination among IBERVILLE PARISH and its district partners within the Acadiana Watershed District is critical to reducing flood risks and preserving the health, safety, and welfare of the residents and property owners of IBERVILLE PARISH;

**WHEREAS**, the Acadiana Planning Commission is hereby designated as the public fiscal agent and administering entity for the Acadiana Watershed District and whose office shall serve as the domicile for the same

**NOW, THEREFORE, BE IT RESOLVED** that the Acadiana Watershed District will enter into a cooperative endeavor agreement with the Acadiana Planning Commission for the purpose of IBERVILLE PARISH becoming a full participant and member of the Acadiana Watershed District and designating the Acadiana Planning Commission as the administrator for the Acadiana Watershed District.
