The Parish Council of Iberville Parish, State of Louisiana, met in Regular Session, in the Council Meeting Room, 2nd Floor, Courthouse Building, 58050 Meriam Street, Plaquemine, Louisiana, on the 23rd day of July, 2024.

The Council Chairman, Matthew H. Jewell, called the meeting to order at 6:30 p.m. followed by the roll call with the following Council Members in attendance: Shalanda L. Allen, District 1; Chasity B. Chief Administrative Officer- Dwayne Boudreaux and Legal Counsel- Scott Stassi were also in attendance.

A quorum was present and due notice had been posted and published in The Advocate newspaper on the 18th day of July, 2024. The Pledge of Allegiance followed.

Council Chairman Jewell called for anyone wanting to make public comments to register with the Clerk. No one registered to speak.

PRESENTATIONS AND APPEARANCES

- A) Audit Presentation by Baxley & Associates Ms. Margaret Pritchard
 - Ms. Margaret Pritchard, representing Hugh Baxley and Associates, LLC. Presented the 2023 Iberville Parish Comprehensive Annual Financial Report.
 - Ms. Pritchard began summarizing page 18 of the audit report which is the statement of net position. Total assets for the year was \$276,987,916 which increased \$13 million over the previous year. Capital assets increased by \$4.3 million. The total liabilities were \$33,140,868. The total net position was \$250,084,957 which increased \$20.9 million for the year.
 - Ms. Pritchard began summarizing page 19 which is the statement of activities. The expenses for governmental funds was \$47,631,619. The business type activities for water, natural gas, and sewer totaled \$8,620,320. The primary governmental total for charges for services was \$56,252,939. The total general revenues and transfers was \$60,084,109 increased over \$8.5 million. The change in net position was \$22 million for the year 2023.
 - Ms. Pritchard began summarizing page 152 of the financial statement audit. There were one finding for the 2023 budget. Procedures have been put in place to monitor the budget in accordance with State laws.
 - Ms. Pritchard went over page 165 which was the agreed upon procedures page. There were 28 procedures with 1 finding.
 - Ms. Pritchard thanked the Finance Director and the Finance Department for a great job in putting together the Comprehensive Annual Financial Report.

President Daigle reported on the following:

- He stated that on August 10, the Iberville Chamber of Commerce will be hosting their annual event, Dancing with the Stars. Kyle Grace will be representing Iberville Parish.
- He stated that on Saturday July 27 at the Mike Zito Center there will be a Surplus Property and vehicle auction. A list of the items included in the auction was presented to the Council in their packets.
- The Summer Worker program will come to an end on Friday, July 26. He encouraged the Councilmembers to reach out to the Summer Workers and see how they enjoyed their summer job.
- He stated that the Grosse Tete Bridge Pedestrian ferry will be switching to a larger vessel to accommodate more people with the influx of travelers with school starting in the next few weeks. The hours will also be changing with this new vessel.
- There will also be a Community Meeting on July 25 that the School Board is hosting to address concerns with parents about children getting to and from school with the bridge closure.
- The Bayou Pigeon Boat Launch will be going out for bid soon, looking for that to be done in the next 30 days.

FINANCIAL REPORT

Finance Director, Randall Dunn stated that the council received budget to actual financial statements for the month. He stated that the revenue went down in the Utility Department because last year was a mild winter so gas sales went down. He is keeping an eye out on that loss and will be watching it closely.
