PRESIDENT'S REPORT

President Daigle reported on the following:

- He recognized Clayton Howard for 20 years of service, Kristi McPhate for 10 years of service and Charles Neely for 5 years of service to Iberville Parish.
- The HWY 1 drainage project is still ongoing due to the City's water line. They are coming up with a plan to move forward with the project and not interfere with the City's water line.
- The new boom truck is coming in this week and the other one should be coming in soon. Crews are working to clear any main drainage ditches in the Parish to prepare for hurricane season.
- They Hwy 30 school zone safety flashing sign has been approved by the State, the Bayou Pigeon Boat Launch should be completed by the end of the year, the speed limit caution signs have been begging to be installed around the Parish, the Bayou Blue water park contract has been signed and work should start in the next 30-60 days. The library renovations will start soon at the smaller branches, the St. Gabriel drainage ditch behind Margaret drive should begin soon, just waiting on the right of way before work can begin. The State is changing the 3 bridges on Hwy 404 and the Callegan Road bridge.
- He stated that these are a few grants that the Parish has received over the last few months, Grosse Tete Bayou Clean up for \$900,000, the Greener Grounds Grant, for \$3,000, the Seymourville Drainage Ditch grant for \$300,000.
- There are some upcoming events that he wanted to highlight as well, on October 4 will be Employee Family Fun Day, October 21 will be Wear Pink Day, and November 11 will be the Veterans Day event.

FINANCIAL REPORT

ORDINANCE TO AMEND THE 2025 TOURISM SPECIAL REVENUE FUND BUDGET IN THE AMOUNT OF \$70,000 FROM THE STATE OF LOUISIANA DEPARTMENT OF CULTURE RECREATION AND TOURISM

WHEREAS, the Iberville Parish Council has identified the need to maintain the Plaquemine Lockhouse

WHEREAS, the Iberville Parish Finance Department certifies that with this amendment and acceptance of state funding there are funds available in the Tourism Special Revenue Fund to maintain the Plaquemine Lockhouse; and

WHEREAS, the Iberville Parish Council recognizes that the maintenance of the Plaquemine Lockhouse is needed in order to operate;

NOW, THEREFORE, BE IT ORDAINED by the Iberville Parish Council that the 2025 Tourism Plaquemine Locks Special Revenue Fund Budget amended as follows:

- An additional amount of seventy thousand dollars (\$70,000) is hereby appropriated in the Tourism Plaquemine Locks Special Revenue Fund in the following revenue account Tourism Plaquemine Locks Special Revenue Fund – 118, IGR - Operating - Culture, Recreation, Tourism - 1355, Plaquemine Locks Account – 7254, State Grants – Culture, Recreation & Tourism - 433035
- 2. An additional amount of seventy thousand dollars (\$70,000) is hereby appropriated in the Tourism Plaquemine Locks Special Revenue Fund in the following expenditure account Tourism Plaquemine Locks Special Revenue Fund 118, Culture and Recreation 55, Plaquemine Locks Account 7254, Maintenance Miscellaneous 526900.

ORDINANCE IPC# 000-25

ORDINANCE TO AMEND SECTION 11-1 OF ARTICLE 1 OF CHAPTER 11 OF THE COMPILED ORDINANCES OF IBERVILLE PARISH, RELATIVE TO THE PERMISSIBLE HEIGHT OF GRASS AND WEEDS

WHEREAS, the legislative power of the Parish Government is vested in the Parish Council; and

WHEREAS; the Parish Council has the authority to enact and amend ordinances providing for the safety, health, and welfare of the residents of Iberville Parish; and

WHEREAS, in order to provide for the safety, health, and welfare for individuals living in Iberville Parish, the Parish has historically regulated the permissible height of grass on properties located within the Parish; and

WHEREAS, the Parish Council desires to amend its ordinance regulating the height of grass and weeds within the Parish.

THEREFORE, BE IT ORDAINED BY THE PARISH COUNCIL FOR THE PARISH OF IBERVILLE:

SECTION 1. Section 11-1 of Article I of Chapter 11 (Health & Sanitation) of the Compiled Ordinances of the Parish of Iberville is hereby amended and reenacted to read as follows:

Sec. 11-1 – Trimming of weeds and grass; notice to cut; causing to cut and collecting of cost.

- (a) It shall be unlawful for the owner of any tract of land, which tract of land is located adjacent to another tract containing a residential or commercial building, to allow the height of any weeds or grass located on said property to exceed nine (9) inches in height. This provision shall not apply to portions of land that are properly planted and cultivated for agricultural purposes, pastureland upon which livestock is routinely present, or forested areas.
- (b) Upon notification to the parish council that an owner of a lot or lots is in violation of subsection (a), the council will notify said owner by registered or certified letter and by placing a sign, which sign is at least one square foot in area, within the road right of way of the property being investigated, notifying him of the violations and that the grass and obnoxious weeds must be cut and removed within fifteen (15) days. In the event the certified/registered letter is delivered to the owner's address, the fifteen (15) day period shall run from the date of the delivery of the letter. In the event the certified/registered letter is undeliverable or unclaimed, the fifteen (15) day period shall run from the date the sign was posted in the right-of-way.
- (c) If after fifteen (15) days the owner of said lot has not cut and removed the grass and obnoxious weeds, the council shall have authority to have such grass and obnoxious weeds cut and removed by a private contractor who will be chosen from the lowest quote or by the use of council manpower and equipment.

- (d) The lot owner then will be charged twenty-five dollars (\$25.00) per lot plus the cost of the private contractor, if a private contractor is used by the council. If the council uses its own manpower and equipment to cut and remove the grass and obnoxious weeds, the parish manager shall determine the cost. Upon completion of such work by a private contractor or by the council, the parish manager shall prepare a certificate showing the cost of such work, the name of the owner and a description of the property and shall mail a copy of said certificate to the property owner. If the charges are not paid within fifteen (15) days of the date of mailing of the copy of the certificate, the parish manager shall file a certified copy of said charges with the parish tax collector to be added to the annual ad valorem tax bill of the property involved.
- (e) The Iberville Parish Council may undertake the cutting, destruction or removal of noxious grass/weeds or other deleterious, unhealthful, or noxious growths on any property within Iberville Parish, excluding the boundaries of any municipality, on a monthly basis or as necessary, without the notice required in subsections (b) and (c) of this section, if the property owner liable has been notified pursuant to said subsections (b) and (c) at any time during the immediately preceding twelve-month period and has failed to do the work himself or after having an opportunity to do so. Prior to undertaking any additional cuttings within the twelve-month period, the Parish shall post, for five consecutive days prior to the cutting, a sign on the property notifying interested parties of the current violation and need to remedy same. The sign shall be at least one square foot in area. Additionally, prior to undertaking such additional cuttings, the parish governing authority, through its designated inspector shall file and record an affidavit signed by the inspector at its administrative office with the Iberville Parish Clerk of Court, which affidavit shall include the following information:
 - (1) Description of the property sufficient to reasonably identify it.
 - (2) A date-stamped photograph of the property sufficient to reasonably identify its unsafe or unsanitary condition and to justify the necessity for cutting, destroying, or removing weeds, grass or other noxious growths.
 - (3) A statement that the property owner liable has within the past twelve (12) months failed to do such work after proper notification and opportunity to do so pursuant to subsection (b) of this section.

Within sixty (60) days of the parish or its designee performing the necessary work to abate the noxious weeds or grass or other deleterious, unhealthful, or noxious growths, the parish shall file a notice of lien/privilege in the Iberville Parish Mortgage Record, in accordance with law.

- SECTION 2. All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the Code hereby adopted are hereby repealed.
- SECTION 3. The Parish Council of the Parish of Iberville, State of Louisiana hereby declares that should any section, paragraph, sentence, or word of this ordinance or of the Code hereby adopted be declared for any reason to be invalid, it is the intent of the Parish Council that it would have passed all other portions of this ordinance, independent of the elimination of any such portion as shall be declared invalid.
- SECTION 4. The ordinance shall take effect and be in force beginning on October 1, 2025.
- SECTION 5. RESOLUTION IPC# 2025- 000

RESOLUTION ADOPTING THE ANNUAL CERTIFICATION OF COMPLIANCE WITH THE STATE OF LOUISIANA OFF SYSTEM BRIDGE REPLACEMENT PROGRAM

WHEREAS, the Code of Federal Regulations, as enacted by the United States Congress, mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity, and posted in accordance with the National Bridge Inspection Standards, and that an inventory of these bridges be maintained by each state; and

WHEREAS, the responsibility to inspect, rate, and load post those bridges under the authority of Iberville Parish, in accordance with those Standards, is delegated by the Louisiana Department of Transportation and Development to Iberville Parish.

NOW, THEREFORE, BE IT RESOLVED by the governing authority of Iberville Parish (herein referred to as the Parish) that the Parish in regular meeting assembled does hereby certify to the Louisiana Department of Transportation and Development (DOTD) that for the period of January 1, 2026 through December 31, 2026:

- 1. The Parish will perform all interim inspections on all parish-owned or maintained bridges in accordance with the National Bridge Inspection Standards and Specifications for the National Bridge Inventory;
- 2. All bridges owned or maintained by the Parish will be structurally analyzed and rated by the Parish as to the safe load capacity in accordance with the American Association of State Highway and Transportation Officials (AASHTO) Manual for Bridge Evaluation. The load posting information that has been determined by DOTD for all bridges where the maximum legal load under Louisiana State Law exceeds the load permitted under the operating rating as determined above will be critically reviewed by the Parish. Load posting information will be updated by the Parish to reflect all structural changes, any obsolete structural ratings, or any missing structural ratings;
- 3. All Parish-owned or maintained bridges which require load posting or closing will be load posted or closed in accordance with the table in the DOTD Load Rating Directives. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting; and
- 4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by the DOTD are noted.
- 5. All bridges owned and maintained by the Parish are accessible to DOTD for all routine bridge inspections. Parish will clear vegetation as required upon DOTD request.

These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.
